It is your responsibility to inspect all items prior to you placing the Absentee Bid. **ALL SALES ARE FINAL. Blue Skies Auction, Inc., offers this service as a convenience at no charge to their customers and will not be held responsible for error or failure to execute bids.**
- A valid credit card with expiration date is required, even though you may choose to pay for the item using another means of payment. However, unless otherwise indicated, payment for successful bids will be placed on the credit card left on your absentee form. **CREDIT CARD NUMBERS ARE NOT KEPT ON FILE**
- Successful bidders must pick up purchases made within 24 hours of the auction, unless other arrangements are made and are responsible for packing and shipping costs of all purchases. Please contact us if you have questions about pick up.
- Absentee bids are executed in competition with the audience, on an alternate basis. Due to the uncertainties of bidding patterns, a lot may sell to the audience for the same amount authorized by an absentee bidder. A (+) sign to the right of bid amount will authorize Blue Skies Auction, Inc. to bid one additional bid. The Absentee Bid received first will take precedence.
- If your Absentee Bid is successful, you will be contacted at the end of the auction to arrange for pick-up. You will **NOT** be notified if your bid was unsuccessful.
- Successful bids are to be paid for immediately. In the event that items purchased by absentee are not completely paid for within 24 hours, Blue Skies Auction, Inc., will assess a 3% interest charge per month on any part thereof that remains unpaid, plus storage and transportation fees.
- Any applicable sales tax or Buyer’s Premiums are not included in your Absentee Bid amount and will be added to the final bid to obtain the final selling price.
- All bids accepted will be executed subject to our Terms and Conditions of Sale as published and available upon request.
- Due to the quantity of absentee bids, no special instructions can be followed. Please bid knowing you may succeed at all bids you leave.
- **All Absentee Bids submitted via fax must be received no later than 5pm, one business day prior to auction. Absentee Bids submitted in person should be received no later than 30 minutes prior to the start of the auction. We may be unable to properly handle your bid after that time.**
